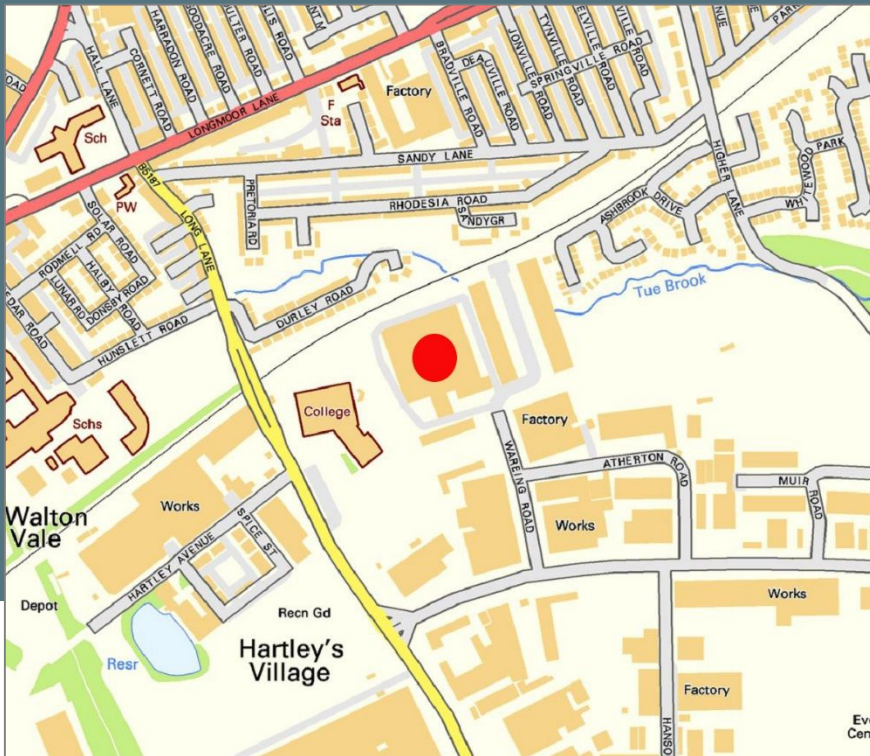
LOCATION

Description

The accommodation comprises of semi-detached high bay warehouse/workshop units situated within a secure site.

The units benefit from a minimum clearance height of 9m to the underside of the haunch.

The units have level concrete floors throughout and are arranged beneath pitched roofs which incorporate 15% translucent roofing sheets. The units benefit from their own yard areas which are surfaced in concrete hard standing.

The space can incorporate 5-7 separate high roller shutter access points.
